
**ORDER ESTABLISHING  
A UNIFORM ORDER OF PROTECTION  
FIRST PAGE**

---

There is need for a uniform first page for Orders of Protection containing comprehensive information that would enable such orders to be readily recognizable and enforceable in the Navajo Nation and surrounding jurisdictions. Such a first page having been established by Project Passport, a national effort to create regionally recognized protective order forms to enhance protective order enforcement by encapsulating all of the necessary legal language on the first page of the form; and this page having been amended for use by consensus of all Navajo Nation Justices and Judges at the last Quarterly Judicial Conference in Tuba City,

**IT IS THEREFORE ORDERED THAT** all of the courts of the Navajo Nation shall use the attached first page for all Orders of Protection, effective this date.

### WARNINGS TO RESTRAINED PARTY:

This order shall be enforced, even without registration, by the courts of any state, the District of Columbia, any U.S. Territory, and may be enforced by Tribal Lands under 18 U.S.C. Section 2265. Crossing state, territorial, or tribal boundaries to violate this order may result in federal imprisonment under 18 U.S.C. Section 2262.

As a result of this order, it may be unlawful for you to possess or purchase ammunition or a firearm, including a rifle, pistol or revolver, under 18 U.S.C. Section 922(g)(8). If you have any questions whether federal law makes it illegal for you to possess or purchase a firearm, you should consult an attorney.

Only the court can change this order.
